Profile

Katherine Wyers is an information systems researcher with a background in software engineering in the humanitarian and commercial sectors. She grew a commercial startup company to be operational in nine countries and then moved into the humanitarian space in 2017 to work as a software engineer on refugee and migrant health and education projects in South-East Asia and Africa. In her research, she studies how identity recategorization by governments shapes collaboration and policy implementation among institutional stakeholders, and shapes access to health and welfare programmes for citizens. She completed her doctoral research at the Department of Informatics, University of Oslo, where she studied the consequences of gender recategorization in dropdown menus, digital technologies, and identity documents, a research project that was based on an ethnographic study of transgender and gender diverse people in north India. Katherine is an editor at the Information Technology for Development journal and reviews for ICIS, ECIS, ITD, AOM, EJISDC and several other outlets in the information systems, ICT4D, informatics, public health, and management disciplines.
